

TERMS AND CONDITIONS Christmas Draws.

THE PROMOTION

- 1. Christmas Draw (the Promotion) commences on 1/12/2024 9am and ends on 24/12/2024 at 7.30pm (the Promotion Period).
- 2. The Promoter is Box Hill RSL 26-28 Nelson Road Box Hill Victoria 3128

ELIGIBILITY REQUIREMENTS

- 3. Entry into this Promotion is open to Box Hill RSL Members. Box Hill RSL warrants that membership of the program does not require the entrant to agree to receive any gaming machine advertising.
- 4. In order to be eligible to participate in the Promotion, a person must be aged 18 years or over and must be a member of the Program administered at Box Hill RSL which is participating in the Promotion (Entrant).

ENTRY

- 5. All entries into the Promotion will be generated by the Promoter via the computer software used to deliver the Program.
- 6. Entrant will automatically receive an entry into the promotion when using their Premium Rewards or Box Hill RSL Membership card.
- 7. Members will receive additional entries as follows:
 - a. Life 4 entries
 - b. Service 4 entries
 - c. Affiliate 3 entries
 - d. Social 2 entries
 - e. Premium rewards 1 entry
- 8. Rewards points are automatically converted into promotional entry into the monthly promotion at a rate of 20 points = 1 entry
- 9. All entries will be placed into a barrel at 7.15pm for the manual draw at 7.30pm everyday from 1/3/2024 to 28/3/2024.
- 10. All entries will be removed after each draw.

DRAW DATES:

- All entries will be placed into a barrel manual draw at 7.30pm every day from 1. 1/12/2024 to 24/12/2024. (24 draws)
- 2. The daily winner will select the prize from the calendar based on the date of the draw at reception. I.e. Winner on the 2/12/2024 will select box 2.

PRIZE POOL:

INVALID DRAWS/ENTRIES

If the Promoter reasonably suspects that a drawn Entrant or Winner is not eligible, has breached these Terms and Conditions, or has acted improperly to increase their chances of winning the Prize, the Promoter reserves the right to refuse to award the Prize to that drawn Entrant or Winner and conduct a re-draw for the Prize that the drawn Entrant or Winner would otherwise have won.

- 11. The Promoter accepts no responsibility for lost, late, illegible or misdirected entries.
- 12. The Promoter reserves the right to cancel or change the Prize (or any part of it) if there are any changes to the law, which would or might render any aspect of the Promotion or the Prize unlawful. The Promoter reserves the right to substitute the Prize (or any part of it) for an item or items of similar value.

To the extent that a situation or issue arises for which these Terms and Conditions make no provision or in relation to which the relevant Terms and Conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue in its sole and absolute discretion and such decision will be final and binding.
