

## TERMS AND CONDITIONS

### WIN! A LUXURY SYDNEY HARBOUR EXPERIENCE

#### THE PROMOTION

#### ELIGIBILITY REQUIREMENTS

3. Entry into this Promotion is open to Box Hill RSL customers.
4. To be eligible, entrants must:

  - Purchase a Robert Oatley product during the Promotion Period (the *Entrant*).
